- 1. The Government of Samoa has received financing from the Asian Development Bank (ADB) towards the cost of Samoa **Power Sector Expansion Project**. Part of this financing will be used for payments under the contract named above. This contract will be jointly financed by Japan International Cooperation Agency, Government of Australia through Department for Foreign Affairs and Trade and Asian Development Bank. Bidding is open to bidders without nationality restrictions. The eligibility rules and procedures of the ADB will govern the bidding process.
- 2. **The Electric Power Corporation (the Employer)** invites sealed bids from eligible bidders for the design, manufacture, supply and install an additional 2MW generator and all associated control equipment at Taelefaga Hydro Power Station.
- 3. Interested bidders must demonstrate their ability to undertake the above mentioned works and meet the criteria as set out in the bidding documents which include:
 - (i) Minimum average annual turnover of US\$2 million as calculated as total certified payments received for contracts in progress or completed, within the last three (3) years.
 - (ii) Experience under contracts in the role of contractor, subcontractor, or management contractor for at least the last three (3) years prior to the application submission deadline.
 - (iii) Participation as contractor, management contractor, or subcontractor, in at least one (1) contract within the last three (3) years, with a value of US\$2 million or at least of the value of the contract has been successfully or is substantially completed and that are similar to the proposed plant and services.
- 4. International competitive bidding will be conducted in accordance with ADB's Single-Stage: One-Envelope bidding procedure and is open to all Bidders without nationality restriction.
