1. The Government of Samoa (GoS) has secured funding from the Global Environment Facility (GEF) Trust Fund and the United Nations Development Program (UNDP) for Improving the Perfor-mance and Reliability of Renewable Energy Power Systems in Samoa (IMPRESS) Project.

- 2. The objective of the project is the improved sustainable and cost-effective utilization of indigenous renewable energy (RE) resources for energy production in Samoa. This will be realized through development of RE and Demand Side Management (DSM) /Energy Efficiency (EE) policies and regulatory frameworks, adoption of RE-based technologies in electricity generation and financing RE, and DSM/EE investments in Samoa. The project comprises the five (5) components: i) Enhancement of Renewable Energy Policy Formulation and Implementation; ii) RE-based Energy System Improvements; iii) Financing of Initiatives for Electricity Saving, Productive and Social Uses of RE Electricity, and Electricity System Performance Improvement; iv) Productive & Social Uses of RE; and v) Enhancement of Awareness on the Applications and Benefits of RE/EE.
- 3. The Engineering, Procurement, and Construction of the 750kW Afolau Biomass Gasification System will be financed under component (ii) of the IMPRESS Project with the EU-GIZ co-financing certain components of the project.
- 4. Ministry of Natural Resources & Environment (MNRE), Samoa Trust Estate Corporation (STEC) and the Samoa Electric Power Corporation (EPC) ("the Employer") jointly invites sealed bids from qualified and experienced bidders for the design, construction, qualified and experienced bidders for the design, construction, installation, testing, commissioning and providing training for 750kW Afolau Biomass Gasification System. The scope will comprise mainly of the Design, Procurement, Construction, Installation and Commissioning of a Biomass Drying Unit, Gasifier, Gas Cleaning System, Syngas Engine, Generator, Exhaust Stack Unit, Transformer, Switchgear(s), and ALL Auxiliary equipment. The scope for design and construction covers the powerhouse, drying shed and ALL related equipment. The Facility will be located at Afolau on the island of Upolu, 30km west of the capital Apia.

The main qualification criteria are: Minimum average annual turnover of US\$3.0 million. b) Cash-flow requirement, US\$0.3million, and the overall cash flow requirements for this contract and its current works commitment. Experience under similar contracts in the role of contractor, subcontractor, operator or management contractor for at least the last five(5) years prior to the bid submission deadline. d)Participation as contractor, management contractor, operator or subcontractor, in at least three (3) contracts within the last ten (10) years, each with a value of at least US\$1.0 million that have been successfully or are substantially completed and that are similar to the proposed plant and services. The similarity shall be based on the physical size, complexity, methods, technology or other characteristics as described in Section 6 (Employer's Requirements). e) Successful completion of manufacture, supply, installation, testing and commissioning of a Biomass Gasification System (Biomass Drying Unit, Gasifier, Gas Cleaning System, Syngas Engine, Generator, Exhaust Stack Unit) for a project similar in size of that proposed f) Successful completion of the design, manufacture, supply and installation, testing and commissioning of Control/ Protection system for a project similar in size to that proposed. g) Other requirements for construction experience in key activities are contained in Section 3 of the

6. International Competitive Bidding will be conducted in accordance with Government of Samoa Single-Stage, Single-Envelope Bidding procedure and is open to all Bidders from eligible countries as described in the Bidding Document.
