Question/ Request 1: Section 1.0 of the bid specifications (page-3a) provides a line for a monthly and annually dollar amount for 1 "LOT" to "provide the Guam Power Authority with a 60-Month Copier Lease Agreement, inclusive of Multifunction Equipment, Maintenance Services, Consumables and Software Solution, Includes a total monthly allowance of *448,000 Black/White prints and 54,000 Color Prints shared between machines"

Can you please confirm that:

- 1.) The amount to be entered into the provide lines for Section 1.0 are a monthly and annual aggregate total for prices for hardware (in 1.08 through 1.0H), and software solutions (identified in 1.0A) to include maintenance and consumables?
- 2.) And if confirmed, will these provided amounts in Section 1.0 be the basis for evaluating the lowest cost bid offer (assuming all indicated bid specifications are met?)

Question/ Request 2: Initially the bid called for a "Pooled Lease Agreement". Amendment VI removed the reference to a "Pool" in the bid title and Section 1.0. However, Section 1.0 of page 3a still requires the inclusion of "a total monthly allowance of *448,000 Black/White prints and 54,000 Color Prints shared between machines."

Can you please confirm if GPA still requires that all devices (IB through IH) share in the total print allowance of 442,000 Black/White prints and 54,000 Color Prints (which is effectively a pool plan without specifically calling it a pool plan)?

An analogy would be a "family share" cell phone plan with 5 cell phones. Under the family share plan, a certain number of minute allowance e.g. 1500 minutes/mo is provided and it doesn't matter which of the 5 cell phones are used. You get one invoice (instead of 5 separate invoices) and as long as you stay within the 1500 minutes each month, there are no additional charges.
