Award will be made after consideration of the following factors as marked below:

- Lump Sum Fixed Price CIF Landed on Majuro, Republic of the Marshall Islands
- Quality and Quantity of materials/equipment offered as per requirements above.
- Delivery Timeframe of within 10 weeks from award
- Payment Terms

- Company profile/past performance/reference letters
- Warranties and certificates including safety certificates
- Technical or service support program

Closing dates for Quotations:

Interested vendors should submit a quote for the services as described in this RFQ. Proposals are due to the following electronic bidding tenderlink address by **3:00PM. on August 2nd, 2019.** Offers received after the closing date will be rejected and submission disqualified.

Method of Submission of Quotation:

Submission of quotations shall be done electronically through e-Tender Box on TenderLink <https://www.tenderlink.com/mecrmi/>. Manual/hardcopy/emailed/fax submission is not allowed.

The electronic submission procedures shall be:

- (i) Proposers or Vendors that are not yet registered with TenderLink are required to register as supplier to enable downloading of the tender documents. Please click on the 'Registration' tab of the portal: <https://www.tenderlink.com/mecrmi/>;
- (ii) Upload your price quotation or proposal on the e-Tender Box before the time and date indicated herein. The submission box will close on the said deadline.
- (iii) To ensure your quotation or proposal is received before the closing deadline, we strongly recommend that you allow sufficient time to upload your proposal submission files.

Validity of Price Quoted:

90 days from the date of submission of the quotation.

MEC reserves the right to reject any and all Requests for Proposals submitted for any reason, if in MEC's sole opinion to do so would be in MEC's best interest.
