INVITATION TO BID (ITB): NOTICE IS HEREBY GIVEN that, in accordance with the American Sāmoa Power Authority Procurement Rules §5-103, ASPA will sell at a Public Sealed-Bid Auction the following surveyed vehicles on *Friday, March 22, 2024 at 10:30AM*. All sealed bids must be turned in to the ASPA Procurement Office located at the ASPA Tafuna Compound, Utu Abe Malae Operations Center. All vehicles and equipment will be sold in an "as is — where as" condition, with no warranties or representations, to the highest bidder.

INSPECTION: Vehicles may be inspected at the ASPA Tafuna Auto Shop between <u>9:00Am to 2:00PM on Monday, March 11, 2024 through Thursday, March 21, 2024</u> (Monday-Friday only; no weekends).

BID DEPOSITS: NO BID DEPOSIT(S) WILL BE REQUIRED.

BID OPENING: A public bid opening will be held on Friday, March 22, 2024 at 10:30AM at the Procurement Conference Room. Attendance is mandatory.

MINIMUM BIDS: The minimum bid is indicated on the auction list next to the legal description. Bids offered must be equal to or more than the minimum bid listed. Bids less than the minimum will be rejected.

ATTENDANCE IS MANDATORY. Principal Bidder or their Proxy must be present at the opening of bids. Proxy by phone, or any other method that does not include a physical presence, will not be allowed.

All vehicles and equipment must be paid for in cash or cashiers check at the time of the sale and before the title and vehicle will be released. NO PERSONAL CHECKS. Vehicles and equipment must be removed from the premises at the expense of the purchaser no later than 4:00PM, two (2) business days after the vehicles have been paid for in full.

will not be opened or considered and will be designated as non-responsive. Attendance at the bid opening by the principal bidder or their designated proxy is mandatory.

No oral, telephonic, email or facsimile proposals will be considered. No late proposals will be accepted. Bids will be publicly opened and read on March 22, 2024 at the closing time of 10:30AM. All vehicles and equipment will be sold on an "as is, where is" condition, with no warranties or representations, to the highest bidder. Procedures as listed below shall be applied to all the bidders submitting a bid:

- 1. All vehicles will be sold on an "as is, where is" condition. No other exception.
- 2. All Sales are final.
- 3. All vehicles and heavy equipment will be sold to the highest bidder.
- 4. The winning highest bidder is given up until 4:00PM March 22, 2024, to pay for his/her vehicle.
- 5. The winning highest bidder shall pay for his/her vehicle to the ASPA Customer Service and submit his/her receipt to the ASPA Procurement Office.
- 6. Vehicles purchased from ASPA are to be removed from ASPA's Tafuna compound within the same day of bid opening date unless permission by the ASPA Procurement Office is otherwise given.
- 7. If the winning highest bidder fails to pay his/her vehicle on the day designated to make payment on, then the vehicle/equipment will be awarded to the 2nd highest bidder.
- 8. The 2nd highest bidder will then follow steps 1-7. If the 2nd winner does not follow through on the payment as detailed above, ASPA will move to the next highest bidder. These procedures will be continued until the vehicle/equipment is sold.
- 9. **EQUAL BIDS.** In the rare case when two or more low bids are equal in all respects, the award will be decided by drawing lots or other random means of selection.
- 10. **REFUNDS.** ASPA will not refund any payments made. Bidders are responsible for inspecting vehicles and heavy equipment prior to bid opening.
- 11. ATTENDANCE IS MANDATORY. Principal bidder or their proxy must attend the bid opening.

The American Sāmoa Power Authority reserves the right to:

- Reject all bids and reissue a new or amended ITB
- Request additional information from any bidder
- Select a bidder for award based on meeting terms, conditions and required specification in this ITB
- Waive any non-material violations of rules set up in this ITB at its sole discretion
