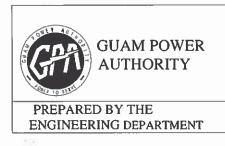

1.0 SCOPE

- 1.1 This specification covers GPA requirements for single-phase, looped, dead-front, 60 Hz, mineral oil filled, 65° C rise pad mounted type distribution transformers for use with separable insulated high-voltage connectors.
- 1.2 The transformer is intended for use in tropical weather conditions with a corrosive sea air atmosphere, sustained wind strengths of 155 MPH with gusts to 180 MPH and subject to moderate and severe earthquakes.

2.0 APPLICABLE PUBLICATIONS

3.0 DEVIATIONS AND NON-CONFORMANCE REQUIREMENTS

- 3.1 Deviations from this specification or changes in the material or design after the purchase order has been placed must be approved by the GPA Engineering Department and acknowledged by a Purchase Order Amendment issued by GPA.
- 3.2 Units received with deviations or non-conformances that are not acknowledged per Section 3.1 are subject to rejection. The Supplier of rejected units is responsible for any corrective action including but not limited to materials, labor and transportation necessary to dispose of or make the units conform to the specification.
- 3.3 Notification of defective units discovered before or after installation that are believed to be inherent to manufacturing problems or workmanship shall be made and forwarded to the Supplier. The description of the item, documentation of the problem and the described information, disposition and/or follow-up (as appropriate) that GPA expects from the Supplier will be specified. The Supplier's response shall be made within thirty (30) days unless an extension is acknowledged and approved in writing by the GPA Manager of Engineering.
- 3.4 Warranty the Supplier shall warrant the distribution transformer to be free from defects in material and workmanship under normal use and service conditions. The term of the Warranty shall be the lesser of twelve (12) months from the date of initial installation or eighteen (18) months from date of receipt.
- 3.5 Statement of Compliance The Supplier shall provide a signed statement verifying that the products being supplied fully comply with the specifications and drawings. Items not in full compliance with the specification and drawings will be identified with a description of the deficiency and any proposed substitutions. Items not in full compliance with the specifications and drawings must be approved by the GPA Engineering Department, as described in Section 3.1.

- 4.2 Information for initial bid review shop drawings shall include:
 - a. Mounting dimensions
 - b. Location of equipment, devices and terminals
 - c. Estimated Weight
 - d. Estimated Number of gallons of oil
 - e. Sample Nameplate Data

- 4.3 After award of contract, final shop drawings indicating full details of construction and the outline of all connectors shall be submitted to GPA Engineering for review and approval. Information for FINAL shop drawings shall include:
 - a. Mounting dimensions
 - b. Location of equipment, devices and terminals
 - c. Actual Weight
 - d. Actual Number of gallons of oil
 - e. Nameplate Data
 - f. Connection diagrams
 - g. Guaranteed full loss at 100% voltage and load
 - h. Guaranteed no-load loss at rated voltage
- 4.4 GPA shall be allowed two (2) weeks to review and approve final shop drawings provided in Section 4.3.1 without affecting the shipping date. Delays in delivery due to drawings that are disapproved during this review period are the responsibility of the Supplier.
- 4.5 Drawings returned to the Supplier as approved shall be considered authorization to proceed with the work. The approval of GPA shall in no way abrogate the requirements of this specification.

5.0 CERTIFIED LABORATORY TEST REPORTS

5.1 Certified tests shall be conducted in accordance with ANSI C57 plus a standard production impulse test. Transformers shall have passed all required tests demonstrating compliance with the design requirements and industry standards.

- 5.2 The Supplier shall also conduct tests to determine transformer load and no-load losses. This test data shall be certified as true and correct by an independent testing firm and submitted to the Authority.
- 5.3 The Supplier shall furnish two (2) copies of the certified test reports of all tests covered by this specification to the GPA Manager of Engineering prior to shipment.

6.0 LOSS EVALUATION

- 6.1 Each bidder shall submit with his bid the guaranteed load and no-load losses on each transformer submitted. Guaranteed load losses shall be provided at 85° C and shall be stated at the nominal voltage tap positions.
- 6.2 Guaranteed losses will be evaluated by GPA to determine the equivalent cost for owning and operating each transformer. The value of the transformer no-load and load losses will be determined by GPA at the time of purchase to arrive at the projected Total Cost of Ownership (TCO) as follows:

- 6.3 A Band of Equivalence method will be used when evaluating the total cost for owning and operating each transformer. Transformers with a TOC that is within 5% of the transformer with the lowest TOC will be considered equivalent. The transformer with the lowest purchase price within this band shall be considered the lowest bid.
- GPA will review actual, certified load and no-load losses for each transformer. In the event the actual losses exceed the guaranteed losses, the Supplier's contract will be reduced. The price reduction shall be the difference between the guaranteed losses and the actual losses at the rates indicated above. Load and no-load loss penalties will be assessed independently. 7.0 RATINGS

- 7.6 The transformer shall meet the latest energy efficiency standards for liquid immersed distribution pad mounted transformers required by the United States Department of Energy.
- 7.7 The Average Winding Rise shall be 65°C

8.0 DESIGN

8.1 Taps

- a. Unless otherwise specified, taps shall be furnished on the high voltage winding. Tap ratios shall conform to ANSI C57 for all transformers, with two 2½ % taps above and below the rated voltage.
- b. Taps shall be full KVA rated and have short circuit capability noted in ANSI C57.
- c. The selection of the tap desired shall be obtained through the operation of an externally operated switch.
 - 1. The switch shall be designed for de-energized operation.
 - 2. The switch assembly shall be snap action or the handle designed to permit checking that a switching operation has been completed.
 - 3. The switch assembly shall be designed to prevent accidental operation.
 - 4. Tap positions shall be clearly marked near the switch handle and on the transformer nameplate.
 - 5. A clearly legible yellow sign in accordance with 9.10.c shall be located adjacent to the handle which identifies it as the tap changer handle and includes a warning to not operate energized.

d. The tap changer operating handle shall be located either in the low-voltage compartment, above the low-voltage bushings or hot stick operable at the high voltage compartment without interfering when primary or secondary cables are installed.

8.2 Protection

- a. Transformers shall be supplied with primary bayonet-type, oil-immersed fuses with isolation links.
- b. Fuse links shall be replaceable without requiring cutting or grinding of the transformer tank.
- c. Bayonet fuses with isolation links shall meet the following requirements:
 - A yellow sign in accordance with 9.11.c reading "CAUTION READ BAYONET OPERATING INSTRUCTION BEFORE RE-FUSING" shall be located adjacent to bayonet fuses.
 - 2. A closed-end trough or catch basin shall be provided to prevent oil dripping on cables and terminations.
 - 3. Free clearance shall be provided for hot stick operation of bayonet fuses.

All transformers covered by this specification shall have an automatic pressure relief valve installed above the hottest temperature oil level in the low voltage compartment, near the right hand most edge to the right of the top bushing to prevent oil dripping on cables and terminations and to prevent spraying.

9.0 CONSTRUCTION

- 9.1 The transformer shall consist of a welded transformer tank which shall be sealed with a welded cover. The enclosure, tank, doors and base of the transformer (the part that makes contact with the mounting surface) shall be made of Type 304L stainless steel.
- 9.2 The transformer shall be equipped with a flip-top hood with heavy duty 3/8" removable stainless steel hinge pins. The high and low voltage compartment including hood, hinges, base and other exterior parts and accessories on the high and low voltage compartment shall be made of Type 304L stainless steel.
- 9.3 A 2 point lifting provision minimum shall be provided to allow for level lifting.
- 9.4 The manufacturer shall identify the type of steel and the thickness of the metal in inches or in gage size, in which case the gage name shall be specified.
- 9.5 No part of the transformer shall allow deformation or standing water. The top of the transformer shall be convex so water will run off the top.
- 9.6 The transformer shall have an oil level gauge, fill plug, drain valve, and self-actuating pressure relief device.
- 9.7 An indication shall be provided for signifying the correct oil level at 25° C if fill plug is not at this level.
- 9.8 Bushings and Terminals
 - a. High voltage separable insulated connector bushings.
 - 1. 200A loadbreak bushing wells and inserts shall be provided. The

- 2. Bushings shall be bonded to tank having a maximum resistance between high voltage bushing shielding and tank of 5000 ohms.
- 3. Weatherproof protective caps shall be installed to remain in position during shipping and storage and not deteriorate prior to installation of transformer.

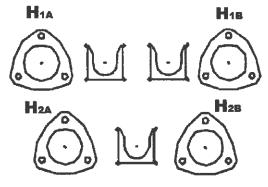


FIGURE 1. 13800 kV Delta Loop Feed Bushing Configuration

- 4. 13,800V delta connected 2 bushing transformers shall be single-phase, dead-front and loop fed with (4 total primary bushings). 2 bushings line A in and 2 bushings line B out as shown in Figure 1 below.

b. Low voltage terminals

- 1. Low voltage terminals shall be NEMA four (4) hole spade for bolting copper terminal lugs.
- 2. Low voltage terminals shall be plated for copper or aluminum cable terminations.
- 3. The low voltage neutral shall be fully insulated and **provided with a** connected, removable neutral ground strap, which shall be connected so as not to impair the bolted secondary connections.

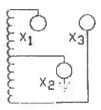


FIGURE 3. Secondary Configuration. Type 1 ANSI

- 4. Low voltage terminals shall be ANSI Type 1 configuration as shown in figure 3. Sufficient clearance shall be allowed between terminal, side of cabinet and floor for termination of cables.

- c. The transformer shall have high and low voltage bushings which are externally clamped and replaceable without requiring access to the inside of the tank.
- d. Ground nuts for grounding connection shall be provided with ground connector for #4 to 2/0 copper wires.

9.9 Security Requirements

Access to the transformer compartment shall be secured by a minimum of two independent locking arrangements.

- a. The transformer locking design shall meet the requirements of the Western Underground Committee Guide 2.13, latest revision, "Security for Pad Mounted Equipment Enclosures."
- b. The transformer shall be designed to prevent wire entry and pass the

following production quality control and receiving inspection test procedure:

- 1. Any length of #12 AWG medium hard drawn solid bare copper wires shall be inserted into each opening until the wire enters the compartment or reaches an obstacle.
- 2. If the wire reaches an obstacle, it can be bent and extended a maximum of three times at which time it shall be considered that the wire cannot be inserted into the enclosure.
- 3. Entry of the wire into a compartment shall constitute a lack of tamper resistance and shall be cause for rejection. It is not necessary for the wire to actually contact energized components since entry into the compartment can establish potential contact conditions.
- c. The locking design shall be adequately sized for a standard padlock. The padlock shall not protrude beyond the front of the hood when installed.
- d. Access door shall be secured by a recessed, captive, pentahead bolt which threads into a noncorrosive nut with a blind hole to prevent the bolt from falling out of the door and a standard padlock.
- e. Low profile cabinets, with access flip-up hoods, need only padlock and pentahead bolt provisions, and shall be coordinated to prevent insertion of the padlock into the hasp until the bolt head is essentially completely seated.
- f. The padlocking device shall be so designed and located so as to resist prying or breaking off by screwdrivers, wrecking bars, tire irons, single-socket lug wrenches, or other readily accessible tools.
- g. Hinge pins shall be passivated AISI type 304 stainless steel or equivalent corrosion-resistant metal.

9.10 Finish Requirements

a. The tank, compartment and all appurtenances shall be resistant to impact and corrosion under normal operating conditions in Guam's salt air environment.

- 1. The total external dry-film thickness of the paint shall be 3.5 mils minimum or equivalent protection and 2.0 mils minimum on the interior compartment surfaces.

- 3. The nameplate shall have rounded corners, and shall not be mounted more than '4" from the surface so as not to constitute a personnel hazard during bare hand secondary make up.

10.0 QUALITY CONTROL

- 10.1 The Supplier shall have a quality control program to ensure compliance with the requirements of this specification. The program shall be documented and available for GPA's review if requested.
- 10.2 Documentation of the quality control program shall indicate where in the production and manufacturing process the quality checks are taken, describe the purpose of the checks, and describe the nature of the check, e.g. if check is visual only or if electrical or mechanical testing is used.

11.0 PACKING AND SHIPPING

- 11.1 The supplier shall have adequate work and inspection instructions for handling, storage, preservation, packaging and shipping to protect the quality of the transformer and all attachments and to prevent damage, loss and deterioration of the transformer and its appurtenances.
- 11.2 The transformer shall be placed and crated with suitable material to prevent damage and injury during shipment and handling operations.
- 11.3 The transformer shall be securely blocked to prevent shifting during transit.

- 5.1 Certified tests shall be conducted in accordance with ANSI C57 plus a standard production impulse test. Transformers shall have passed all required tests demonstrating compliance with the design requirements and industry standards.
- 5.2 The Supplier shall also conduct tests to determine transformer load and no-load losses. This test data shall be certified as true and correct by an independent testing firm and submitted to the Authority.
- 5.3 The Supplier shall furnish two (2) copies of the certified test reports of all tests covered by this specification to the GPA Manager of Engineering prior to shipment.

6.0 LOSS EVALUATION

- 6.1 Each bidder shall submit with his bid the guaranteed load and no-load losses on each transformer submitted. Guaranteed load losses shall be provided at 85° C and shall be stated at the nominal voltage tap positions.
- Guaranteed losses will be evaluated by GPA to determine the equivalent cost for owning and operating each transformer. The value of the transformer no-load and load losses will be determined by GPA at the time of purchase to arrive at the projected Total Cost of Ownership (TCO) as follows:

- 6.3 A Band of Equivalence method will be used when evaluating the total cost for owning and operating each transformer. Transformers with a TOC that is within 5% of the transformer with the lowest TOC will be considered equivalent. The transformer with the lowest purchase price within this band shall be considered the lowest bid.
- 6.4 GPA will review actual, certified load and no-load losses for each transformer. In the event the actual losses exceed the guaranteed losses, the Supplier's contract will be reduced. The price reduction shall be the difference between the guaranteed losses and the actual losses at the rates indicated above. Load and no-load loss penalties will be assessed independently. Bonuses will not be awarded for actual losses which are less than guaranteed. Any transformer with no-load losses or load losses greater than the tolerances indicated in ANSI C57 shall be rejected by the Authority.

7.0 RATINGS

- 7.1 The primary voltage rating is 13,800 V line to line.
- 7.2 Secondary Voltage rating shall be either 208Y/120V or 480Y/277V as required.
- 7.3 The insulation class is 15 kV and the primary-voltage BIL is 95 kV.
- 7.4 The required transformer kVA ratings will be indicated on the purchase order. See Table 1 for GPA pad mounted transformer kVA ratings.

- 7.5 The transformer impedance shall be as indicated in Table 1. ANSI tolerances may be applied to these values. The impedance value shall be provided on the nameplate.
- 7.6 The transformer shall meet the latest energy efficiency standards for liquid immersed distribution pad mounted transformers required by the United States Department of Energy.
- 7.7 The Average Winding Rise shall be 65°C

8.0 DESIGN

- 8.1 High Voltage Taps Changer
 - a. Unless otherwise specified, taps shall be furnished on the high voltage winding. Tap ratios shall conform to ANSI C57 for all transformers, with two 2½ % taps above and below the rated voltage.
 - Taps shall be full KVA rated and have short circuit capability noted in ANSI C57.

- c. The location of the tap changer switch shall be placed so that it is easily accessible and not directly below the primary bushing so it is not blocked by the primary wires.
- d. The selection of the tap desired shall be obtained through the operation of an externally operated switch.
 - 1. The tap changer switch shall be designed for de-energized operation.
 - The tap changer switch assembly shall be snap action or the handle designed to permit checking that a switching operation has been completed.
 - 3. The tap changer switch assembly shall be designed to prevent accidental operation.
 - 4. Tap positions shall be clearly marked near the switch handle and on the transformer nameplate.
 - 5. A clearly legible yellow sign in accordance with 9.14.c shall be located adjacent to the handle which identifies it as the tap changer handle and includes a warning to not operate energized.
- e. The tap changer operating handle shall be located either in the low-voltage compartment, above the low-voltage bushings or hot stick operable at the high voltage compartment without interfering when primary or secondary cables are installed.

8.2 Protection

- a. Transformers shall be supplied with primary bayonet-type, oil-immersed fuses with isolation links.
- b. Fuse links shall be replaceable without requiring cutting or grinding of the transformer tank.
- c. Bayonet fuses with isolation links shall meet the following requirements:
 - 1. A yellow sign in accordance with 9.14.c reading "CAUTION READ BAYONET OPERATING INSTRUCTION BEFORE RE-FUSING"

- 2. A closed-end trough or catch basin shall be provided to prevent oil dripping on cables and terminations.
- 3. Free clearance shall be provided for hot stick operation of bayonet fuses.
- 4. Bayonet fuses with isolation links shall be sized in accordance with Table 2.

- d. Provide an externally operated load break oil rotary (LBOR) switch for radial feed on the primary side. The switch shall have two positions, open and closed and shall be placed away from the primary bushing and not directly below so it is not blocked by the primary wires.
- e. All transformers covered by this specification shall have an automatic pressure relief valve installed above the hottest temperature oil level in the low voltage compartment, near the right hand most edge to the right of the top bushing to prevent oil dripping on cables and terminations and to prevent spraying.

9.0 CONSTRUCTION

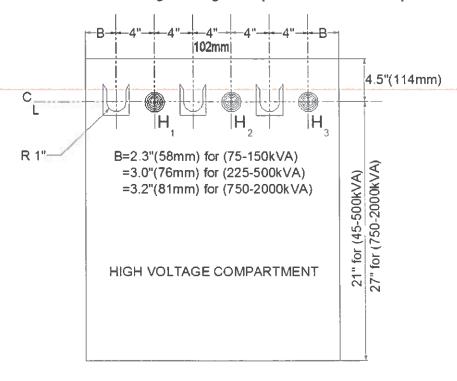
- 9.1 The transformer shall consist of a welded transformer tank which shall be sealed with a welded cover. The enclosure, tank, doors and base of the transformer (the part that makes contact with the mounting surface) shall be made of Type 304L stainless steel.
- 9.2 The high and low voltage compartment including the door, door handles, hinges, base and other exterior parts and accessories shall be made of Type 304L stainless steel.
- 9.3 A 2 point lifting provision minimum shall be provided to allow for level lifting.
- 9.4 The manufacturer shall identify the type of steel and the thickness of the metal in inches or in gage size, in which case the gage name shall be specified.
- 9.5 No part of the transformer shall allow deformation or standing water. The top of the transformer shall be convex so water will run off the top.
- 9.6 The transformer shall have an oil level gauge, fill plug, drain valve, and self-actuating pressure relief device.
- 9.7 An indication shall be provided for signifying the correct oil level at 25° C if fill plug is not at this level.
- 9.8 The transformer shall be supplied with a high and low voltage compartment barrier. The compartment barrier shall be removable.
- 9.9 The compartment with separable insulated high voltage connectors shall be covered by a single door.
- 9.10 Bushings and Terminals
 - a. High voltage separable insulated connector bushings.
 - 1. 15 kV, 200A loadbreak bushing wells and inserts shall be provided. The Supplier shall provide approved load break bushing insert(s), Elastimold 1601A4 or approved equal.
 - 2. Bushings shall be bonded to tank having a maximum resistance

between high voltage bushing shielding and tank of 5000 ohms.

- 3. Weatherproof protective caps shall be installed to remain in position during shipping and storage and not deteriorate prior to installation of transformer.
- 4. Configuration of the high voltage bushing wells and parking stands shall be as shown in Figure 1.

b. Low voltage terminals

- 1. Low voltage terminals hole counts shall be as designated in Table 1. Spade dimensions shall be as shown below in Figure 2.
 - a. Dimensions between centerline of holes shall be 1.75 inches plus or minus 0.03in (44.5mm plus or minus 0.8mm) both vertically and horizontally.
 - b. Thickness of spade shall be 0.25 inches (6mm) or greater as required to meet rated ampacities.
 - c. Hole diameters must be 0.56 inches(14.3mm) plus or

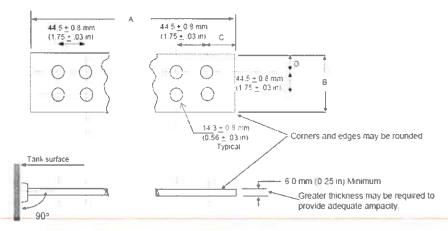

FIGURE 2. Spade Dimensions

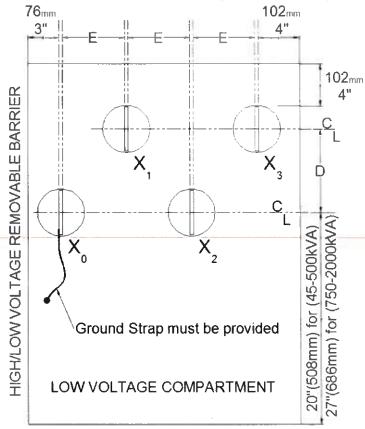


- 2. Low voltage terminals shall be plated for copper or aluminum cable terminations.
- 3. The low voltage neutral shall be fully insulated and provided with a connected, removable neutral ground strap, which shall be connected so as not to impair the bolted secondary connections.
- 4. Low voltage terminals shall be staggered as shown below in Figure 3 per ANSI C57.12.34-2004.

- c. The transformer shall have high and low voltage bushings which are externally clamped and replaceable without requiring access to the inside of the tank.
- d. Ground nuts/lugs for grounding connection to the grounding pads shall be provided with ground connector for #4 to 2/0 copper wires.
- e. Ground pads shall be provided on both the high and low voltage compartments. Ground pads shall conform to ANSI C57.12.34-2004 section 9.11. Where high and low voltage compartments are separated, these ground pads must be

electrically bonded.

f. Secondary bushing spade supports shall be furnished on all three phase transformers. Spade support method shall attach to the spade in an independent hole other than the cable connection holes. Spade support mounting shall be of insulating material with adjustable means to increase or decrease tension. Cross members of the spade supports shall be mounted off the cabinet wall and compartment separation barrier or to top of the transformer. Spade support components shall be designed to be easily removed and reassembled for assembly of cable to secondary spades. Supports must be attached to top of spades and not from the sides or the bottom which will impede the installation of cables.

9.11 Security Requirements

Access to the transformer compartment shall be secured by a minimum of two independent locking arrangements.

- a. The transformer locking design shall meet the requirements of the Western Underground Committee Guide 2.13, latest revision, "Security for Pad Mounted Equipment Enclosures."
- b. The transformer shall be designed to prevent wire entry and pass the following production quality control and receiving inspection test procedure:
 - 1. Any length of #12 AWG medium hard drawn solid bare copper wires shall be inserted into each opening until the wire enters the compartment or reaches an obstacle.
 - 2. If the wire reaches an obstacle, it can be bent and extended a maximum of three times at which time it shall be considered that the wire cannot be inserted into the enclosure.
 - 3. Entry of the wire into a compartment shall constitute a lack of tamper resistance and shall be cause for rejection. It is not necessary for the wire to actually contact energized components since entry into the compartment can establish potential contact conditions.
- c. Access into the transformer shall be secured by a recessed, captive pentahead bolt which threads into a noncorrosive nut with a blind hole

to prevent the bolt from falling out of the door and a standard padlock.

- d. The padlocking device shall be so designed and located so as to resist prying or breaking off by screwdrivers, wrecking bars, tire irons, single-socket lug wrenches, or other readily accessible tools.
- e. Hinge pins shall be passivated AISI type 304 stainless steel or equivalent corrosion-resistant metal.
- f. The secondary compartment door shall be latched at a minimum of three points. In addition to the three-point latching, one pentahead bolt shall be coordinated with the latch and padlock to prevent unlatching and insertion of the padlock into the hasp until the bolt head is essentially completely seated, respectively.

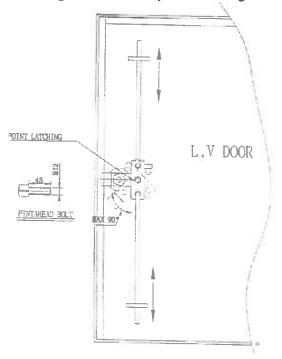


Figure 4 – Three-point latching of Low Voltage Door

g. Per ANSI C57.12.34-2004 section 9.3, the high-voltage door shall be secured separately from the low voltage door and entry into the high voltage door can only be done after opening the low-voltage door. The high-voltage door shall be secured with a bolt, preferably 5/8" to 11/16V

This is to allow work on the low voltage side of the transformer while the high voltage side is secured.

- h. The locking design shall be adequately sized for a standard padlock. The padlock shall not protrude beyond the front of the hood when installed. Hexagonal head bolts shall be Y2 inch and shall be of non-corrosive metal.
- i. The height of the padlock and pentahead provision shall be located near the center of the low voltage door and shall be no higher than 5 feet from the base of the transformer.

9.12 Finish Requirements

- a. The tank, compartment and all appurtenances shall be resistant to impact and corrosion under normal operating conditions in Guam's salt air environment.
 - 1. The total external dry-film thickness of the paint shall be 3.5 mils minimum or equivalent protection and 2.0 mils minimum on the interior compartment surfaces.
 - All mating surfaces shall be designed to prevent degradation of corrosion protection, e.g. abrasion and impact. Mating surfaces at sill/hood junction shall be designed to prevent standing water corrosion.
 - 3. Surfaces in contact with, and a minimum of two inches above, the mounting surface shall be designed or treated to be resistant to corrosion and abrasion when unit is skidded and slid into place on the mounting pad.
- b. The transformer shall withstand the following environmental tests for 2000 hours:
 - 1. ASTM B117, Standard Method of Salt Spray (Fog) Testing.
 - 2. Ultraviolet Test, per ASTM D822. Standard Recommended Practice for Operating Light and Water Exposure Apparatus (Carbon-Arc type) for testing paint, varnish, lacquer and related products (ASTM G23 TypeD or better).

9.13 Transformer Identification and Labeling Requirements

- a. High voltage and low voltage terminal designations shall be located directly above their respective terminals.
- b. Transformer KVA rating, designated high voltage nameplate and designated low voltage nameplate shall be located inside the door and plainly visible with door open.
- c. Signs shall be yellow stenciled or approved decals. Decals shall have yellow printing on a black or clear background, or black printing on a yellow background, reverse printed on Scotch Cal material with pressure sensitive adhesive or an equivalent approved by GPA Engineering.

d. Nameplate

- 1. The nameplate shall be made of corrosion resistant material and shall comply with applicable industry standards for distribution transformers.
- 2. The nameplate shall be permanent showing all of the required information, including KVA, voltage rating, ratio, BIL, weight, winding material, month and year of manufacture, impedance, high voltage and low voltage material, etc.
- 3. The nameplate shall have rounded corners, and shall not be mounted more than ¼" from the surface so as not to constitute a personnel hazard during bare hand secondary make up.

10.0 QUALITY CONTROL

- 10.1 The Supplier shall have a quality control program to ensure compliance with the requirements of this specification. The program shall be documented and available for GPA's review if requested.
- 10.2 Documentation of the quality control program shall indicate where in the production and manufacturing process the quality checks are taken, describe the purpose of the checks, and describe the nature of the check, e.g. if check is visual only or if electrical or mechanical testing is used.

11.0 PACKING AND SHIPPING

- 11.1 The supplier shall have adequate work and inspection instructions for handling, storage, preservation, packaging and shipping to protect the quality of the transformer and all attachments and to prevent damage, loss and deterioration of the transformer and its appurtenances.
- 11.2 The transformer shall be placed and crated with suitable material to prevent damage and injury during shipment and handling operations.
- 11.3 The transformer shall be securely blocked to prevent shifting during transit.

SPECIAL PROVISION FOR OWNERSHIP & INTEREST DISCLOSURE AFFIDAVIT

All Bidders/Offerors are required to submit a current affidavit as required below. Failure to do so will mean disqualification and rejection of the Bid/RFP.

5 GCA §5233 (Title 5, Section 5233) states: Disclosure of Ownership, Financial, and Conflicts of Interest

(a) Purpose. The disclosure required by this Section are intended to reveal information bearing on the responsibility of a bidder, and can be obtained by an inquiry regarding responsibility prior to award.

(b) Definitions.

As used herein, the term "person" shall be interpreted liberally to include the definition found in 1 GCA § 715, and in § 5030(n) of this Chapter, and includes a natural person as well as every entity of whatever form or composition (an "artificial person") recognized under the laws of Guam other than a natural person, who is a prospective contractor under a bid, offer, proposal, or other response to a solicitation, or is a contractor under a contract with the government of Guam, and subject to the provisions of this Chapter.

(c) Public Disclosure of Ownership.

- (1) The ownership interests to be disclosed under this Section include the interests of a natural or artificial person who owns all or any part of a prospective contractor, bidder, or offeror, whether as proprietor, a partner, limited or otherwise, a shareholder of any class, in which case the percentage ownership interest test shall be based on each class, a member of an association or company, limited or otherwise, and any person owning a beneficial legal interest in any trust, and any other person having the power to control the performance of the contract or the prospective contractor.
- Prior to award, every person who is a prospective contractor, bidder, or offeror of a contract to be acquired under any method of source selection authorized by this Chapter shall submit a Disclosure Statement, executed as an affidavit under oath, disclosing the name of each person who currently or has owned an ownership interest in the prospective contractor, bidder, or offeror greater than ten percent (10%) at any time during the twelve (12) month period immediately preceding the date of the solicitation (the "relevant disclosure period"). If a prospective contractor, bidder, or offeror is an artificial person, the Disclosure Statement shall disclose the name of each person who has owned an ownership interest in such artificial person (a "second tier owner") greater than twenty-five percent (25%) at any time during the relevant disclosure period. If any such second tier owner is also an artificial person, the Disclosure Statement shall disclose the name of each person who has owned an ownership interest in such second tier owner (a "third tier owner") of forty-nine percent (49%) or more during the relevant disclosure period. If the name of no natural person has been identified as an owner, or a second or third tier owner of the prospective contractor, bidder, or offeror, the Disclosure Statement shall identify the name, position, address, and contact information of the natural person having the authority and responsibility for the performance of the prospective contract, and the name of any natural person who has the authority and power to remove and replace the designated responsible person or otherwise control the performance of the prospective contract.
- (d) Disclosure of Financial Interest. A prospective contractor shall execute an affidavit disclosing the name of any person who has received or is entitled to receive a commission, gratuity, contingent fee or other compensation to solicit, secure, or assist in obtaining business related to the solicitation by means of a Disclosure Statement, executed as an affidavit under oath, disclosing such interest and shall also contain the amounts of any such commission, gratuity, contingent fee or other compensation.
- (e) Disclosure of Conflict of Interest. A prospective contractor shall disclose the name of any person who directly or indirectly participates in any solicitation if such person is also an employee of the government of Guam, or of the government of the United States if federal funds are used in payment of the contract.

- (f) Every disclosure of an ownership or financial interest of any person required to be identified by this Section shall name the person required to be disclosed and the street address of their principal place of business. All information disclosed or meant to be disclosed under this Section is public procurement data and shall be kept as part of the public record of each procurement.
- (g) Continuing Duty of Disclosure. Notwithstanding any other provision of this Chapter, the duty to disclose the information required under this Section shall be, upon award a continuing duty of a contractor of every contract subject to this Chapter, and all such information shall become part of the procurement record required by § 5249 of this Chapter. Throughout the term of a contract subject to the terms of this Chapter, the contractor shall promptly make any disclosures not made previously and update changes in the identities or other required information, interests, or conflicts of the persons required to be disclosed herein. Failure to comply with this Section shall constitute a material breach of contract."

Section 2. Severability. If any provision of this Act or its application to any person or circumstance is found to be invalid or contrary to law, such invalidity shall not affect other provisions or applications of this Act that can be given effect without the invalid provision or application, and to this end the provisions of this Act are severable.

- 2. Affidavits must be signed within 60 days of the date the bids or proposals are due.

HEALTH & WELFARE: \$5.36 per hour, up to 40 hours per week, or \$214.40 per week or \$929.07 per month

HEALTH & WELFARE EO 13706: \$4.93 per hour, up to 40 hours per week, or \$197.20 per week, or \$854.53 per month*

*This rate is to be used only when compensating employees for performance on an SCA-covered contract also covered by EO 13706, Establishing Paid Sick Leave for Federal Contractors. A contractor may not receive credit toward its SCA obligations for any paid sick leave provided pursuant to EO 13706.

VACATION: 2 weeks paid vacation after 1 year of service with a contractor or successor; and 4 weeks after 3 years. Length of service includes the whole span of continuous service with the present contractor or successor, wherever employed, and with the predecessor contractors in the performance of similar work at the same Federal facility. (Reg. 29 CFR 4.173)

HOLIDAYS: A minimum of eleven paid holidays per year: New Year's Day, Martin Luther King Jr.'s Birthday, Washington's Birthday, Memorial Day, Juneteenth National Independence Day, Independence Day, Labor Day, Columbus Day, Veterans' Day, Thanksgiving Day, and Christmas Day. (A contractor may substitute for any of the named holidays another day off with pay in accordance with a plan communicated to the employees involved.) (See 29 CFR 4.174)

THE OCCUPATIONS WHICH HAVE NUMBERED FOOTNOTES IN PARENTHESES RECEIVE THE FOLLOWING:

1) COMPUTER EMPLOYEES: This wage determination does not apply to any individual employed in a bona fide executive, administrative, or professional capacity, as defined in 29 C.F.R. Part 541. (See 41 C.F.R. 6701(3)). Because most Computer Systems Analysts and Computer Programmers who are paid at least \$27.63 per hour (or

at least \$684 per week if paid on a salary or fee basis) likely qualify as exempt computer professionals under 29 U.S.C. 213(a)(1) and 29 U.S.C. 213(a)(17), this wage determination may not include wage rates for all occupations within those job families. In such instances, a conformance will be necessary if there are nonexempt employees in these job families working on the contract.

Job titles vary widely and change quickly in the computer industry, and are not determinative of whether an employee is an exempt computer professional. To be exempt, computer employees who satisfy the compensation requirements must also have a primary duty that consists of:

- (1) The application of systems analysis techniques and procedures, including consulting with users, to determine hardware, software or system functional specifications;
- (2) The design, development, documentation, analysis, creation, testing or modification of computer systems or programs, including prototypes, based on and related to user or system design specifications;
- (3) The design, documentation, testing, creation or modification of computer programs related to machine operating systems; or
- (4) A combination of the aforementioned duties, the performance of which requires the same level of skills. (29 C.F.R. 541.400).

Any computer employee who meets the applicable compensation requirements and the above duties test qualifies as an exempt computer professional under both section 13(a)(1) and section 13(a)(17) of the Fair Labor Standards Act. (Field Assistance Bulletin No. 2006-3 (Dec. 14, 2006)). Accordingly, this wage determination will not apply to any exempt computer employee regardless of which of these two exemptions is utilized.

2) AIR TRAFFIC CONTROLLERS AND WEATHER OBSERVERS - NIGHT PAY & SUNDAY PAY: If you work at night as part of a regular tour of duty, you will earn a night differential and receive an additional 10% of basic pay for any hours worked between 6pm and 6am. If you are a full-time employed (40 hours a week) and Sunday is part of your regularly scheduled workweek, you are paid at your rate of basic pay plus a Sunday premium of 25% of your basic rate for each hour of Sunday work which is not overtime (i.e. occasional work on Sunday outside the normal tour of duty is considered overtime work).

** HAZARDOUS PAY DIFFERENTIAL **

An 8 percent differential is applicable to employees employed in a position that represents a high degree of hazard when working with or in close proximity to ordnance, explosives, and incendiary materials. This includes work such as screening, blending, dying, mixing, and pressing of sensitive ordnance, explosives, and pyrotechnic compositions such as lead azide, black powder and photoflash powder. All dry-house activities involving propellants or explosives. Demilitarization, modification, renovation, demolition, and maintenance operations on sensitive ordnance, explosives and incendiary materials. All operations involving re-grading and cleaning of artillery ranges.

A 4 percent differential is applicable to employees employed in a position that represents a low degree of hazard when working with, or in close proximity to ordnance, (or employees possibly adjacent to) explosives and incendiary materials which involves potential injury such as laceration of hands, face, or arms of the employee engaged in the operation, irritation of the skin, minor burns and the like; minimal damage to immediate or adjacent work area or equipment being used. All operations involving, unloading, storage, and hauling of ordnance, explosive, and incendiary ordnance material other than small arms ammunition. These differentials are only applicable to work that has been specifically designated by the agency for ordnance, explosives, and incendiary material differential pay.

** UNIFORM ALLOWANCE **

If employees are required to wear uniforms in the performance of this contract (either by the terms of the Government contract, by the employer, by the state or local law, etc.), the cost of furnishing such uniforms and maintaining (by laundering or dry cleaning) such uniforms is an expense that may not be borne by an employee where such cost reduces the hourly rate below that required by the wage determination. The Department of Labor will accept payment in accordance with the following standards as compliance:

The contractor or subcontractor is required to furnish all employees with an adequate number of uniforms without cost or to reimburse employees for the actual cost of the uniforms. In addition, where uniform cleaning and maintenance is made the responsibility of the employee, all contractors and subcontractors subject to this wage determination shall (in the absence of a bona fide collective bargaining agreement providing for a different amount, or the furnishing of contrary

affirmative proof as to the actual cost), reimburse all employees for such cleaning and maintenance at a rate of \$3.35 per week (or \$.67 cents per day). However, in those instances where the uniforms furnished are made of ""wash and wear"" materials, may be routinely washed and dried with other personal garments, and do not require any special treatment such as dry cleaning, daily washing, or commercial laundering in order to meet the cleanliness or appearance standards set by the terms of the Government contract, by the contractor, by law, or by the nature of the work, there is no requirement that employees be reimbursed for uniform maintenance costs.

The contracting officer shall require that any class of service employee which is not listed herein and which is to be employed under the contract (i.e., the work to be performed is not performed by any classification listed in the wage determination), be classified by the contractor so as to provide a reasonable relationship (i.e., appropriate level of skill comparison) between such unlisted classifications and the classifications listed in the wage determination (See 29 CFR 4.6(b)(2)(i)). Such conforming procedures shall be initiated by the contractor prior to the performance of contract work by such unlisted class(es) of employees (See 29 CFR 4.6(b)(2)(ii)). The Wage and Hour Division shall make a final determination of conformed classification, wage rate, and/or fringe benefits which shall be paid to all employees performing in the classification from the first day of work on which contract work is performed by them in the classification. Failure to pay such unlisted employees the compensation agreed upon by the interested parties and/or fully determined by the Wage and Hour Division retroactive to the date such class of employees commenced contract work shall be a violation of the Act and this contract. (See 29 CFR 4.6(b)(2)(v)). When multiple wage determinations are included in a contract, a separate SF-1444 should be prepared for each wage determination to which a class(es) is to be conformed.

The process for preparing a conformance request is as follows:

- 1) When preparing the bid, the contractor identifies the need for a conformed occupation(s) and computes a proposed rate(s).
- 2) After contract award, the contractor prepares a written report listing in order the proposed classification title(s), a Federal grade equivalency (FGE) for each proposed classification(s), job description(s), and rationale for proposed wage rate(s), including information regarding the agreement or disagreement of the authorized representative of the employees involved, or where there is no authorized representative, the employees themselves. This report should be submitted to the contracting officer no later than 30 days after such unlisted class(es) of employees performs any contract work.
- 3) The contracting officer reviews the proposed action and promptly submits a report of the action, together with the agency's recommendations and pertinent information including the position of the contractor and the employees, to the U.S. Department of Labor, Wage and Hour Division, for review (See 29 CFR 4.6(b)(2)(ii)).
- 4) Within 30 days of receipt, the Wage and Hour Division approves, modifies, or disapproves the action via transmittal to the agency contracting officer, or notifies the contracting officer that additional time will be required to process the request.
- 5) The contracting officer transmits the Wage and Hour Division's decision to the contractor.
- 6) Each affected employee shall be furnished by the contractor with a written copy of such determination or it shall be posted as a part of the wage determination (See 29 CFR 4.6(b)(2)(iii)).

Information required by the Regulations must be submitted on SF-1444 or bond paper.

When preparing a conformance request, the ""Service Contract Act Directory of Occupations"" should be used to compare job definitions to ensure that duties requested are not performed by a classification already listed in the wage determination. Remember, it is not the job title, but the required tasks that determine whether a class is included in an established wage determination. Conformances may not be used to artificially split, combine, or subdivide classifications listed in the wage determination (See 29 CFR 4.152(c)(1))."

SPECIAL PROVISIONS

Restriction Against Sex Offenders Employed by Service Providers to Government of Guam from Working on Government of Guam Property

GCA 5 §5253 Restriction Against Contractors Employing Convicted Sex Offenders from Working at Government of Guam Venues:

- (a) No person convicted of a sex offense under the provisions of Chapter 25 of Title 9 Guam Code Annotated, or an offense as defined in Article 2 of Chapter 28, Title 9 GCA in Guam, or an offense in any jurisdiction which includes, at a minimum, all of the elements of said offenses, or who is listed on the Sex Offender Registry, and who is employed by a business contracted to perform services for an agency or instrumentality of the government of Guam, shall work for his employer on the property of the Government of Guam other than public highway.
- (b) All contracts for services to agencies listed herein shall include the following provisions: (1) warranties that no person providing services on behalf of the contractor has been convicted of a sex offense under the provisions of Chapter 25 of Title 9 GCA or an offense as defined in Article 2 of Chapter 28, Title 9 GCA, or an offense in another jurisdiction with, at a minimum, the same elements as such offenses, or who is listed on the Sex Offender Registry; and (2) that if any person providing services on behalf of the contractor is convicted of a sex offense under the provisions of Chapter 25 of Title 9 GCA or an offense as defined in Article 2 of Chapter 28, Title 9 GCA or an offense in another jurisdiction with, at a minimum, the same elements as such offenses, or who is listed on the Sex Offender Registry, that such person will be immediately removed from working at said agency and that the administrator of said agency be informed of such within twenty-four (24) hours of such conviction.
- (c) Duties of the General Services Agency or Procurement Administrators. All contracts, bids, or Requests for Proposals shall state all the conditions in § 5253(b).
- (d) Any contractor found in violation of § 5253(b), after notice from the contracting authority of such violation, shall, within twenty-four (24) hours, take corrective action and shall report such action to the contracting authority. Failure to take corrective action within the stipulated period may result in the temporary suspension of the contract at the discretion of the contracting authority.

- [X] 38. **TERMINATION FOR CONVENIENCE**: Any termination order for the convenience of the Government issued relative towards made under this solicitation will be subject to and in accordance with the provisions of Section 6-101.10 of the Government Procurement Regulations.
- [X] 39. TIME FOR COMPLETION: It is hereby understood and mutually agreed by and between the contractor and the Government that the time for delivery to final destination or the timely performance of certain services is an essential condition of this contract. If the contractor refuses or fails to perform any of the provisions of this contract within the time specified in the Purchase Order (from the date Purchase Order is acknowledged by vendor), then the contractor is in default. Defaults will be treated subject to and in accordance with the provisions of Section 6-101-08 of the Guam Procurement Regulations.
- [X] 40. JUSTIFICATION OF DELAY: Bidders who are awarded contracts under this Solicitation, guarantee that the goods will be delivered to their destination or required services rendered within the time specified. If the bidder is not able to meet the specified delivery date, he is required to notify the Chief Procurement Officer of such delay. Notification shall be in writing and shall be receive by the Chief Procurement Officer at least twenty-four (24) hours before the specified delivery date. Notification of delay shall include an explanation of the causes and reasons for the delay including statement(s) from supplier or shipping company causing the delay. The Government reserves the right to reject delay justification if, in the opinion of the Chief Procurement Officer, such justification is not adequate.
- [X] 41. **PAYMENT TERMS**: NET THIRTY (30) DAYS after receipt of ORIGINAL invoice for goods and/or services rendered.
- [X] 42. LIQUIDATED DAMAGES: When the contractor is given notice of delay or nonperformance as specified in Paragraph 1 (Default) of the Termination for Default Clause of this contract and fails to cure in the time specified, the contractor shall be liable for damages for delay in the amount of one-fourth of one percent (1%) of outstanding order per calendar day from date set for cure until either the territory reasonable obtains similar supplies or services if the contractor is terminated for default, or until the contractor provides the supplies or services if the contractor is not terminated for default. To the extent that the contractor is delay or nonperformance is excused under Paragraph (4) (Excuse for Nonperformance or Delayed Performance) of the Termination for Default Clause of this contract, liquidated damages shall not be due the territory. The contractor remains liable for damages caused other than by delay (GPR Section 6-101-09.1).
- [X] 43. PHYSICAL LIABILITY: If it becomes necessary for the Vendor, either as principal, agent or employee, to enter upon the premises or property of the Government of Guam in order to construct, erect, inspect, make delivery or remove property hereunder, the Vendor hereby covenants and agrees to take, use, provide and make all proper, necessary and sufficient precautions, safeguards and protections against the occurrence of any accidents, injuries or damages to any person or property during the progress of the work herein covered, and to be responsible for, and to indemnify and save harmless the Government of Guam from the payment of all sums of money by reason of all or any such accidents, injuries or damages that may occur upon or about such work, and fines, penalties and loss incurred for or by reasons of the violations of any territorial ordinance, regulations, or the laws of Guam or the United States, while the work is in progress. Contractor will carry insurance to indemnify the Government of Guam against any claim for loss, damage or injury to property or persons arising out of the performance of the Contractor or his employees and agents of the services covered by the contract and the use, misuse or failure of any equipment used by the contractor or his employees or agents, and shall provide certificates of such insurance to the Government of Guam when required.

BID FORMS: Each bidder shall be provided with two (2) sets of Solicitation forms. Additional copies may
be provided upon request. Bidders requesting additional copies of said forms will be charged per page in
accordance with Section 6114 of the Government Code of Guam. All payments for this purpose shall be
by cash, certified check or money order and shall be made payable to the Guam Power Authority.

2. PREPARATIONS OF BIDS:

- a) Bidders are required to examine the drawings, specifications, schedule, and all instructions.
 Failure to do so will be at bidder's risk.
- b) Each bidder shall furnish the information required by the Solicitation. The bidder shall sign the solicitation and print or type his name on the Schedule. Erasures or other changes must be initialed by the person signing the bid. Bids signed by an agent are to be accompanied by evidence of this authority unless such evidence has been previously furnished to the issuing office.
- c) Unit price for each unit offered shall be shown and such price shall include packing unless otherwise specified. A total shall be entered in the amount column of the Schedule for each item offered. In case
 - of discrepancies between a unit price and extended price, the unit price will be presumed to be correct.
- d) Bids for supplies or services other than those specified will not be considered. Time, if stated as a number of days, means calendar days and will include Saturdays, Sundays, and holidays beginning the day after the issuance of a Notice to Proceed. Time stated ending on a Saturday, Sunday or Government of Guam legal holiday will end at the close of the next business day.
- 3. EXPLANATION TO BIDDERS: Any explanation desired by a bidder regarding the meaning or interpretation of the Solicitation, drawings, specifications, etc., must be submitted in writing and with sufficient time allowed for a written reply to reach all bidders before the submission of their bids. Oral explanations or instructions given before the award of the contract will not be binding. Any information given to a prospective bidder concerning a Solicitation will be furnished to all prospective bidders in writing as an amendment to the Solicitation if such information would be prejudicial to uninformed bidders.
- ACKNOWLEDGEMENT OF AMENDMENTS TO SOLICITATIONS: Receipt of an
 amendment to a Solicitation by a bidder must be acknowledged by signing an acknowledgement of
 receipt of the amendment.
 - Such acknowledgement must be received prior to the hour and date specified for receipt of bids.

5. SUBMISSION OF BIDS:

- a) Bids and modifications thereof shall be enclosed in sealed envelopes and addressed to the office specified in the Solicitation. The bidder shall show the hour and date specified in the Solicitation for receipt, the Solicitation number, and the name and address of the bidder on the face of the envelope.
- b) Telegraphic bids will not be considered unless authorized by the Solicitation. However, bids may be modified or withdrawn by written or telegraphic notice, provided such notice is received prior to the hour and date specified for receipt (see paragraph 6 of these instructions).
- c) Samples of items, when required, must be submitted within the time specified, unless otherwise specified by the Government, at no expense to the Government. If not destroyed by testing, samples will be returned at bidder's request and expense, unless otherwise specified by the Solicitation.
- d) Samples or descriptive literature should not be submitted unless it is required on this solicitation. Regardless of any attempt by a bidder to condition the bid, unsolicited samples or descriptive literature will not be examined or tested at the bidder's risk, and will not be deemed to vary any of the provisions of this Solicitation.
- 6. FAILURE TO SUBMIT BID: If no bid is to be submitted, do not return the solicitation unless otherwise specified. A letter or postcard shall be sent to the issuing office advising whether future Solicitations for the type of supplies or services covered by this Solicitation are desired.

7. LATE BID, LATE WITHDRAWALS, AND LATE MODIFICATIONS:

- a) Definition: Any bid received after the time and date set for receipt of bids is late. Any withdrawal or modification of a bid received after the time and date set for opening of bids at the place designated for opening is late (Guam Procurement Regulations Section 3-202)
- b) Treatment: No late bid, late modification, or late withdrawal will be considered unless received before contract award, and the bid, modification, or withdrawal would have been timely but for the action or inaction of territorial personnel directly serving the procurement activity.

8. **DISCOUNTS:**

- a) Notwithstanding the fact that prompt payment discounts may be offered, such offer will not be considered in evaluating bids for award unless otherwise specified in the Solicitation. However, offered discounts will be taken if payment is made within the discount period, even though not considered in the evaluation of bids.
- In connection with any discount offered, time will be computed from date of delivery and acceptance of the supplies to the destination as indicated in the purchase order or contract.
 Payment is deemed to be made for the purpose of earning the discount on the date of mailing of the Government check.

- 9. **GOVERNMENT FURNISHED PROPERTY:** No material, labor or facilities will be furnished by the Government unless otherwise provided for in the Solicitation.
- 10. SELLERS' INVOICES: Invoices shall be prepared and submitted in quadruplicate (one copy shall be marked "original") unless otherwise specified. Invoices shall be "certified true and correct" and shall contain the following information: Contract and order number (if any), item numbers, description of supplies or services, sizes, quantities, unit prices, and extended total. Bill of lading number and weight of shipment will be shown for shipments made on Government bills of lading.
- 11. RECEIPT, OPENING AND RECORDING OF BIDS: Bids and modifications shall be publicly opened in the presence of one or more witnesses, at the time, date, and place designated in the Invitation for Bids. The name of each bidder, the bid price, and such other information as is deemed appropriate by the Procurement Officer, shall be read aloud and recorded, or otherwise made available. The names and addresses of required witnesses shall be recorded at the opening. The opened bids shall be available for public inspection except to the extent the bidder designates trade secrets or other proprietary data to be confidential as set forth in accordance with Section 12 below. Material so designated shall accompany the bid and shall be readily separable from the bid in order to facilitate public inspection of the non-confidential portion of the bid. Prices, makes and models or catalogue numbers of the items offered, deliveries, and terms of payment shall be publicly available at the time of bid opening regardless of any designation to the contrary (Guam Procurement Regulations Section 3-202.12.2).

12. RESTRICTION AGAINST SEX OFFENDERS:

5 GCA Section 5253, enacted by P.L 28-24 and amended by P.L. 28-98:

The service provider warrants that no person in its employment who has been convicted of a sex offense under the provisions of Chapter 25 of Title 9 of the Guam Code Annotated, or of an offense defined in Article 2 of Chapter 28 of Title 9 of the Guam Code Annotated, or who has been convicted of an offense with the same elements as heretofore defined in any other jurisdiction, or who is listed on the Sex Offender Registry shall provide services on behalf of the service provider while on government of Guam property, with the exception of public highways. If any employee of the service provider is providing services on government property and is convicted subsequent to an award of a contract, then the service provider warrants that it will notify the Government of the conviction within twenty-four (24) hours of the conviction, and will remove immediately such convicted person from providing services on government property. If the service provider is found to be in violation of any of the provisions of this paragraph, then the Government will give notice to the service provider to take corrective action. The service provider shall take corrective action within twenty-four (24) hours of notice from the Government, and the service provider shall take corrective action when action has been taken. If the service provider fails to take corrective steps within twenty-four (24) hours of notice from the Government, then the Government in its sole discretion may suspend temporarily any contract for services until corrective action has been taken.

- 13. DISABLED VETERAN OWNED: P.L. 34-115. 5 Guam Code Annotated §5011 & §5012 §5011. Policy In Favor of Service-Disabled Veteran Owned Businesses. Notwithstanding any provision of law, and except for the procurement of professional services, if any entity of the government of Guam or any entity expending governmental funds intends to procure any supply or service, which is offered by a business concern that is at least fifty-one percent (51%) owned by a service-disabled veteran(s), that entity shall procure such supply or service from that business concern, if the supply or service is available within the period required by procuring entity and the price for the supply or service does not exceed one hundred five percent (105%) of the lowest bidder, and shall be in addition to any other procurement benefit the service-disabled veteran owned business may qualify for under Guam Law. §5012. Qualifications of a Service-Disabled Veteran Owned Business. A business concern is qualified under §5011 of this Chapter if:
 - (a.) the business concern is licensed to do business on Guam;
 - (b.) the business concern maintains its headquarters on Guam;
 - (c.) the business concern is at least fifty-one percent (51%) owned by a service-disabled veteran(s) who served in the active U.S. military service, was discharged or released under honorable conditions and whose disability is service-connected as demonstrated by a DD214, and certified by and award letter from the U.S Department of Veterans Affairs;
 - (d.) the DD214 and Disability award letter from the U.S Department of Veterans Affairs are submitted to the procuring entity for every service offered; and
 - (e.) the service-disabled veteran(s) owner of the business concern has filed individual tax returns on Guam for a period of *at least* three (3) consecutive years."
- 14. WOMEN-OWNED BUSINESSES: P.L. 36.26. 5 Guam Code Annotated §5013.

§5013. Policy In Favor of Women-Owned Businesses.

- (a.) Notwithstanding any other provision of law, if any entity of the government of Guam or any entity expending governmental funds intends to procure any supply or service which is offered by a business concern that is at least fifty-one percent (51%) owned by women, that entity shall procure such supply or service from that business concern, if the supply or service is available within the period required by procuring entity and the price for the supply or service does not exceed one hundred five percent (105%) of the lowest bidder, and shall be in addition to any other procurement benefit the women-owned business may qualify for under Guam Law. The procuring entity shall determine the lowest price to the entity in the case of more than one (1) women-owned business, or a women-owned business and a service-disabled veteran owned business, who are competing for the same government contract
- (b.) Qualifications of a Women-Owned Business. A business concern is qualified under Subsection (a) of the Section if:
 - (1) the business concern is licensed to business on Guam;
 - (2) the business concern maintains its headquarters on Guam;

- (3) the business concern is at least fifty-one percent (51%) owned by women, who manage day-to-day operations and make long-term decisions;
- (4) the business concern is certified as a Women-Owned Small Business (WOSB) or an Economically Disadvantaged Women-Owned Small Business (EDWOSB) by the U.S. Small Business Administration; and
- (5) the owner(s) of the business concern has (have) filed individual tax returns on Guam for a period of at least three (3) consecutive years
- 15. CONFIDENTIAL DATA: The Procurement Officer shall examine the bids to determine the validity of any requests for nondisclosure of trade secrets and other proprietary date identified in writing. If the parties do not agree as to the disclosure of data, the Procurement Officer shall inform the bidders in writing what portions of the bid will be disclosed and that, unless the bidders protest under Chapter 9 of the Guam Procurement Act (P.L. 16-124), the bids will be so disclosed. The bids shall be opened to public inspection subject to any continuing prohibition on the disclosure of confidential data (Guam Procurement Regulations Section 3-202.12.3).

16. MULTI-STEP SEALED BIDDING:

- a. It is defined as two-phase process consisting of a technical first-phase composed of one or more steps in which bidders submit unpriced technical offers to be evaluated by the territory, and a second-phase in which those bidders whose technical offers are determined to be acceptable during the first-step have their priced bids considered. It is designed to obtain the benefits of competitive sealed bidding by award of a contract to t h lowest responsive, responsible bidder, and at the same time obtained the benefits of the competitive sealed proposals procedure through the solicitation of technical offers and the conduct of discussions to evaluate and determine the acceptability of technical offers.
- b. In addition to the requirements set forth in the General Terms and Conditions and the Special provisions, the following applies:
 - 1). only unpriced technical offers are requested in the first phase;
 - 2). priced bids will be considered only in the second phase and only from bidders whose unpriced technical offers are found acceptable in the first phase;
 - the criteria to be used in the evaluation at those specified in the Special Provisions and the General Terms and Conditions;
 - 4). the territory, to the extent the Procurement Officer finds necessary, may conduct oral or written discussion of the unpriced technical offers;
 - the bidders, may designate those portions of the unpriced technical offers which contain trade secrets or other proprietary data which are to remain confidential; and,
 - the service being procured shall be furnished generally in accordance with bidder's technical offer as found to be finally acceptable and shall meet the requirements of the Invitation for Bids.

c. RECEIPT AND HANDLING OF UNPRICED TECHNICAL OFFERS.

Unpriced technical offers shall not be opened publicly, but shall be opened in front of two or more procurement officials. Such offers shall not be disclosed to unauthorized persons. Bidders may request nondisclosure of trade secrets and other proprietary data identified in writing.

d. EVALUATION OF UNPRICED TECHNICAL OFFERS.

The unpriced technical offers submitted by bidders shall be evaluated solely in accordance with the criteria set forth in the Invitation for Bids. The unpriced technical offers shall be categorized as:

- 1). acceptable;
- 2). potentially acceptable, that is, reasonably susceptible of being made acceptable; or
- unacceptable. The Procurement Officer shall record in writing the basis for finding an offer unacceptable and make it part of the procurement file.

The Procurement Officer may initiate Phase Two of the procedure if, in the Procurement Officer's opinion, there are sufficient acceptable unpriced technical offers to assure effective price competition in the second phase without technical discussions. If the Procurement Officer finds such is not the case, the Procurement Officer shall issue an amendment to the Invitation for Bids or engage in technical discussions as set forth in Subsection 3-202.20.5of this Section.

e. Upon the completion of Phase One, the Procurement Officer shall invite each acceptable bidder to submit a price bid. Upon submission of prices, the Procurement Officer shall prepare the final evaluation and reconsideration for the Chief Procurement Officer's approval.
