SUPPLY OF TWENTY-SIX UNITS OF PHASE SEQUENCE METER WITH ACCESSORIES MR 207/2025

SECTION I - INSTRUCTIONS TO BIDDERS

Notes to Bidders: This section provides detailed information necessary for Bidders to prepare their Bids, in accordance with the requirements specified by Energy Fiji Limited ('EFL'). It also provides information on Bid submission, opening, evaluation and the award of contract.

1. Scope

EFL invites bids for the Supply of twenty-six (26) only complete set of Phase Sequence/Rotation Meters Complete with Accessories (herein referred to as "Phase Rotation meter") as described in the Bidding Document. This unit shall be used to positively identify the phase rotation on an overhead conductor and underground HV (6.6kV/11kV/33kV) and LV cable in a de-energized state.

2. Eligibility of Bidders

- 2.1 This bidding is open to all eligible companies
- 2.2 EFL in its sole unfettered discretion, can disqualify or otherwise determine ineligible any potential Bidder that the EFL believes is, has been or will be, whether directly or indirectly, engaged in criminal or any other unethical behavior, financially unsound, or otherwise unfit in the EFL's opinion to participate in the bidding exercise.
- 2.3 In its Bid, the Bidder shall indicate the origin of Goods proposed i.e. product build in xxxx country.
- 2.3 A Bidder shall not be eligible to participate in this bidding or in the performance of the contract if the bidder:
 - Is bankrupt or being wound up, is having its affair administered by the courts, has entered into an arrangement with creditors, has suspended business activities, is the subject of proceedings concerning those matters or is in any analogous situation arising from a similar procedure provided in national legislation or regulations.
 - Has been the subject of a judgement which has the force of judicator for fraud, corruption, involvement in a criminal organization or any other illegal activity detrimental to the financial interests of EFL.
 - Is guilty of misrepresentation in supplying the information required as a condition of participation in this bidding exercise or fail to supply this information.

3. Bid Prices

- 3.1 The Bidder shall indicate on the appropriate Price Schedule, the unit prices (where applicable) and total Bid Price of the offered goods.
- 3.2 The Bidder's separation of price components will be solely for the purpose of facilitating the comparison of Bids by EFL and will not in any way limit the EFL's right to contract on any of the terms offered.

- 3.3 All non-exempt duties, taxes and other levies payable by the Supplier/Bidder under the Contract/Purchase Order, or for any other cause shall be included in the rates, prices and total Bid price submitted by the Bidder.
- 3.4 Bid prices shall be **CFR basis** and delivered Suva Port, Fiji. Cost and Freight shall be quoted for by the Bidder. EFL has its own insurance cover for freight.

4. Bid Currency

4.1 Unless otherwise specified in Section II, the unit rates and Prices shall be quoted by the Bidder's Country of Origin.

5. Request for Extension of Bid Submission Period

Any extension request must be made 72 hours prior to tender closure. It shall be EFL's prerogative to either accept or reject the request to extend tender submission deadline.

6. Period of Validity of Goods

- 6.1 Unless otherwise specified in Section II, bids shall remain valid for a period of 90 days after the deadline for the receipt of Bids. A bid valid for a shorter period shall be rejected by EFL as nonresponsive.
- 6.2 In exceptional circumstances, EFL shall may solicit the Bidders' consent to an extension of the period of validity. The request and the responses thereto shall be made in writing.

Section II - Tender Specifications

Description

The Phase Rotation meter should enable safe and reliable cable phasing. It should provide absolute safe and efficient flow of testing on any given cable both indoor and outdoor. The equipment shall be battery powered. Therefore, the Phase Rotation meter must be easy and safe to operate and small for portability. Underground cables which shall be subjected to tests using the Phase Rotation meter range from cables that withstand/carry 240V AC to 33,000V AC.
