2.The Owners Engineer who will also function as the Project Engineer (OE) is responsible to provide guidance and support and will oversee the implementation of the NEAT Project Components.

Should the performance be evaluated as non-satisfactory, the contract will be terminated immediately at the conclusion of the probationary period. A performance appraisal will be undertaken every 12 months for confirmation of continuity.

The OE is expected to perform the services, The consultant generally would work remotely however should be prepared to travel to Port Moresby if requested.
